<u>Re: 40 New Positive COVID-19 Test Results in Hunt County,</u> and Three New Deaths

40 new positive test results for COVID-19 and three new COVID-19 deaths were reported in Hunt County on November 30, 2020, which covers the 5-day period from November 26-30. The Hunt County Health Department completed an initial investigation and determined that the individuals in question reside in Hunt County. The general information for the 40 new patients is on the following page. Hunt County will include up-to-date hospital numbers in the daily report.

The three new deaths were the following Tracked Patients: 2451 – 65+ Female, West Tawakoni, 75474; 2706 – 65+ Male, West Tawakoni, 75474; and 2754 – 50-64 Male, Quinlan, 75474.

Each day, the County will release and post on its website a new set of numbers and charts showing the total number of cases, including the status and ZIP Codes of those cases. The state's website includes a map which may be accessed at "dshs.state.tx.us/coronavirus" by clicking on the "Texas Case Counts" link.

The State's COVID-19 fatality numbers for Hunt County exceed the locally-reported numbers of deaths. The State's reporting can be accessed by clicking on "Fatalities over Time by County" on www.dshs.state.tx.us/coronavirus/additionaldata. As of this evening, the state shows 59 COVID-19 fatalities of Hunt County residents. This divergence is due to the way the State calculates COVID-19 deaths, which in part uses death certificate information not yet available to the County. When Hunt County releases its morning reports, it will show the number of State-reported deaths (59), the number of deaths certificates filed with the County Clerk's office (including non-citizen deaths) (57), and the number of County-citizen deaths that the County Health Department has been able to independently confirm (38).
